1. Introduction

The Company has today announced a conditional placing, open offer and subscriptions to raise up to approximately £37.6 million (before expenses) by the issue and allotment by the Company of an aggregate of up to 376,000,000 new Ordinary Shares at the Offer Price of 10 pence per Ordinary Share (assuming that the Placing and Open Offer are fully subscribed).

The Placing will raise £30.0 million (before expenses) by the issue and allotment by the Company of 300,000,000 new Ordinary Shares at the Offer Price (assuming that the Placing is fully subscribed).

In addition, in order to provide Shareholders who have not taken part in the Placing with an opportunity to participate in the proposed issue of new Ordinary Shares, the Company is providing all Qualifying Shareholders with the opportunity to subscribe at the Offer Price for an aggregate of 16,000,000 Offer Shares, to raise up to £1.6 million (before expenses), on the basis of 4 new Ordinary Shares for every 11 existing Ordinary Shares, at 10 pence each, payable in full on acceptance.

Furthermore, Nikhil Gandhi and ITD have agreed to subscribe for, and the Company has agreed to issue, in aggregate 60,000,000 new Ordinary Shares at the Offer Price on or following Admission, representing subscription proceeds of £6.0 million in aggregate, on such terms as are further described at paragraph 8 of this document.

The receipt of the Transaction proceeds is conditional, *inter alia*, upon Shareholders approving Resolutions 1 and 2 at the General Meeting that will grant to the Directors the authority to allot the New Ordinary Shares and the power to disapply pre-emption rights set out in the articles of incorporation of the Company in respect of the New Ordinary Shares, and Admission. The Resolutions are contained in the Notice of General Meeting at the end of this document. Admission is expected to occur no later than 8.00 a.m. on 25 November 2016 or such later time and/or date as Cenkos Securities and the Company may agree (not being later than 8:30 a.m. on 16 December 2016). The Transaction is not underwritten.

The Open Offer provides Qualifying Shareholders with an opportunity to participate in the proposed issue of the New Ordinary Shares on a pre-emptive basis whilst providing the Company with additional capital to invest in the business of the Group. The Offer Price is at a discount of 4.8 per cent. to the closing middle market price of 10.5 pence per Existing Ordinary Share on 28 October 2016 (being the last practicable date before publication of this document).

The purpose of this document is to explain the background to and reasons for the Transaction, the use of proceeds, the details of the Transaction and to recommend that you vote in favour of the Resolutions.

2. Background on the Company

The Company is a Guernsey registered holding company quoted on the AIM market of the London Stock Exchange. The Group's main activity, to date, has been the preparation for, and construction of, the Multi-purpose Terminal and the Logistics Park (together, the "Facility") located at Karanja Creek, a high growth industrial zone near Navi Mumbai. The construction of the Facility was delayed due to a number of factors but work on site has continued without material interruption since October 2015 and, subject to securing the Funding, the Directors expect the Facility to be fully operational by end of the third quarter of 2017.

The Facility at a glance

Once completed, the Project Land which will comprise approximately 200 acres of reclaimed land with 1,000 metres of sea frontage and the Facility is expected to have the following specifications:

- a port with an annual capacity of approximately 8 million tonnes per annum;
- six berths serviced by cranes capable of handling bulk, container and general cargo;
- a waterway which is capable of accommodating 4,000 DWT vessels with a draft of up to 4.5 metres; and
- warehousing facilities for break-bulk, packaged but non-containerised, cargo.

The Project Land was chosen for its strategic location close to Mumbai, the commercial capital of India, situated eight miles from Jawaharlal Nehru Port ("JNPT"), Mumbai's largest, and heavily congested, container port. The Facility will be well positioned for access to other key commercial infrastructures along the west coast of India including: (i) Mumbai port; (ii) Navi Mumbai International airport; (iii) access to India's national road network; (iv) the proposed Mumbai Trans-Harbour Link; and (v) the proposed Dedicated Rail Freight Corridor. The Directors expect that the location of the Facility will prove to be attractive to end users, particularly those involved in the transport of cargo to supply the large infrastructure projects planned for the west coast of India together with those involved in the transport of cars on the basis that the Facility and its ultimate end users will have access to Mumbai and the west coast of India (see the map below).



Current status and timetable to completion

To date, the Company has achieved the following milestones in relation to the development of the Facility:

- obtained all environmental and planning consents, approvals and authorisations;
- completed all material investigations, surveys and studies;
- designed the civil structures comprising the Facility;
- completed piling for 100 metres of quay;
- completed approximately 60 per cent. of the overall dredging requirement;
- reclaimed approximately 75 acres of land; and
- commenced commercial discussions with potential end users of the Facility.

Whilst the Directors expect that the Facility will be capable of receiving vessels by the end of this year, the Directors are not forecasting revenues from operations until the end of the third quarter of 2017 when, subject to securing the Funding, the Facility is expected to be fully operational. Further details of the Funding are referred to below.

Subject to the Company being able to secure the Funding by the end of the first quarter of 2017, the Company is working to the following timetable in order to achieve full operational completion of the Facility by the end of the third quarter of 2017:

By the end of January 2017 the Company expects to have:

- completed the dredging requirement;
- reclaimed 70 per cent. of the land; and
- constructed two berths, one of which will be capable of receiving vessels.

By the end of the first quarter of 2017 the Company expects to have:

- reclaimed 90 per cent. of the land;
- constructed four berths, three of which will be capable of receiving vessels; and

• entered into commercial agreements with end users.

By the end of the second quarter of 2017 the Company expects to have:

- completed the balance of reclamation work;
- carried out further ground improvement works;
- constructed the remaining berths, four of which will be capable of receiving vessels; and
- completed the sourcing of all necessary equipment.

3. Background to and reasons for the Transaction

The Company has made significant progress in the development and construction of the Facility, which was forecast at the time of the Company's IPO to cost Rs. 7.7 billion (£108.5 million). However, as referred to in the Company's announcement of its 2015 preliminary results on 16 June 2016, discussions with the EPC Contractor were taking place at that time with a view to completing the Facility with the resources available to the Company and, in the context of the delays that had taken place, it was the Directors' view that the discussions with the EPC Contractor were likely to conclude that additional funds would be required to complete the Facility to the desired specification. Discussions have since continued, during which time it has also become apparent that the land that has been reclaimed has settled more than expected. As a result, an additional quantity of infill material will be required, which was not originally budgeted for, and this issue has been further exacerbated by price inflation of quarried infill material since the development of the Facility commenced.

Taking these items together, and considering the working capital requirements of the Company until the Facility is fully operational, in the Company's announcement of its interim results on 22 September 2016, the Directors estimated that the Company had a funding requirement of £36 million. This was based on the total project cost and working capital requirement being £146 million and having spent approximately £61 million, with cash in hand of approximately £24.6 million and £24.1 million available for drawdown under the Debt Facility as at 31 August 2016.

Since that time, whilst there has been a decline in the value of Sterling against the Indian Rupee, the impact of this has been offset through a combination of the negotiation of costs and other actions taken by the Company, such that the funding requirement remains at £36 million.

As described further at paragraph 9 of this Part I, the Relationship Agreement will terminate upon Admission and the Company will no longer have the right to use the word 'SKIL' in its registered name and/or brand name. Accordingly, the Directors also propose to rename the Company, 'Mercantile Ports and Logistics Limited'. If the relevant Resolution is passed, this change of name will take effect shortly after Admission.

4. Market and macro-dynamics

The proximity of the Facility to JNPT is a key factor that the Directors believe will contribute to the Company's success. JNPT is classed as a Major Port and is the primary gateway for container shipments in India, accounting for approximately 55 per cent. of all such shipments. Demand continues to outstrip its capacity, with congestion currently a significant problem at JNPT, despite JNPT's stated aim to become one of the top 10 ports in the world by 2020 with a capacity goal of over 10 million TEUs.

The Directors expect that the continued expansion of JNPT will present significant opportunities for the Company. In particular, the Directors believe that the Company will benefit from the Facility being able to offer:

- mid-stream discharge and loading of cargo at anchorage whilst vessels wait to berth at JNPT;
- coastal movement of cargos such as containers, cement and other break-bulk cargos servicing end users along the industrialised west coast of India; and

• an integrated, high-tech container freight solution at the Logistics Park, easing congestion issues in the road network around Mumbai and JNPT, when coupled with the coastal movement of cargos.

The congestion in India's ports is being experienced at the same time as the Indian economy is forecast to be the seventh largest economy in the world by the end of 2016, with growth in GDP of 7.6 per cent. expected in 2017. The Directors believe that the success of the Group will be enhanced by the continued growth in the Indian economy, especially given India's historic reliance on its ports for its export and import trade ("EXIM"). India's location, surrounded by a coastline of over 7,500 kilometers and with over 14,500 kilometers of navigable inland waterways, means that its ports and logistics industries have historically been relied upon to help facilitate the wider growth of the Indian economy, with India's maritime logistics accounting for 90 per cent. of total EXIM trade by volume and 72 per cent. by value. Such EXIM trade is forecast to grow at 5 to 10 per cent. CAGR over the next decade and the Directors believe that once the Facility is fully operational it will be well positioned to benefit from this projected growth.

Whilst maritime logistics are an important part of the Indian economy, handling more than 1 billion tonnes of cargo in 2015, such water transport only accounts for 7 per cent. of the total freight movement in India in tonne per kilometre terms despite water transport representing significantly lower costs than rail or road freight. This figure compares to 20 per cent. in China.

India's maritime logistics sector is under-utilised when compared to its road and railway logistics sectors, yet India's Major Ports continue to be heavily congested. This results in inefficiencies, such as an average turnaround time (being the time in which a vessel can be loaded or discharged of cargo) of 4.5 days compared to only 1 day and 1.2 days in China and the United States respectively, which the Indian government fears could hamper India's potential for wider economic growth.

Port-led development and efficiencies have, therefore, become a national focus of the Indian government. The Sagarmala initiative was approved by the Indian Government's Ministry of Shipping with the stated aim of "accelerating economic development in the country by harnessing the potential of India's coastline and river network". The Directors believe that this further validates the Group's investment in the Facility to date and represents opportunities once the Facility is fully operational.

The Indian government aims to increase cargo at Indian ports to 2.5 billion tonnes by 2025, from 1.1 billion tonnes in 2015, necessitating increases in capacity and efficiencies at existing ports and the construction of new ports, such as the Facility in order to alleviate congestion. Given that the cost per tonne of using waterway routes in India is 60 to 80 per cent. less than using road or rail, the Directors believe that the government's push towards maximising maritime freight logistics will further enhance the Facility's attractiveness to potential customers, with the added benefit that a multi-modal mix of freight transport is predicted to lead to carbon emissions savings of 3.5 per cent. of India's total freight sector emissions.

The Directors continue to believe that the Facility will have limited direct competition from surrounding Minor Ports along the industrialised west coast of India due to the Facility's close proximity to Mumbai Port and JNPT.

5. Outlook

As at 30 September 2016, on the basis of an exchange rate of Rs. 86.6: £1.00, the Company's cash position was £22.8 million and it had £24.0 million headroom in its Debt Facility. As such, the Directors believe that the Company has sufficient resources to finance the continued construction of the Facility, without delay, through to the end of the first quarter of 2017 and, following receipt of the Transaction proceeds, to complete the Facility by the end of the third quarter of 2017.

Alongside the Company's plan to continue the construction of the Facility to operational completion, there will also be a focus on marketing the Facility to potential customers. The Directors intend, in particular, to focus on potential customers, including a consortium of shipping lines, exporters and importers of containers and break-bulk cargos in the region and coastal cargo given the Indian Government's stated aim to decongest the freight rail and road corridors along the west coast of India by stimulating growth in India's maritime logistics sector.

6. The Placing and Open Offer

Details of the Placing

The Company has conditionally raised £30.0 million before expenses by the conditional placing of 300,000,000 Placing Shares at the Offer Price to the Places (assuming that the Placing is fully subscribed).

The Placing is conditional, inter alia, upon:

- (a) the passing of Resolutions 1 and 2 at the General Meeting;
- (b) the Placing Agreement becoming or being declared unconditional in all respects and not having been terminated in accordance with its terms prior to Admission; and
- (c) Admission becoming effective by no later than 8.00 a.m. on 25 November 2016 or such later time and/or date (being no later than 8.30 a.m. on 16 December 2016) as Cenkos Securities and the Company may agree.

If any of the conditions are not satisfied, the Placing Shares will not be issued and all monies received from the Placees will be returned to the Placees (at the Placees' risk and without interest) as soon as possible thereafter.

The Placing Shares are not subject to clawback. The Placing is not being underwritten.

The Placing Shares will be issued free of all liens, charges and encumbrances and will, when issued and fully paid, rank *pari passu* in all respects with the Existing Ordinary Shares, including the right to receive all dividends and other distributions declared, made or paid after the date of their issue.

Application will be made to the London Stock Exchange for the admission of the Placing Shares to trading on AIM. It is expected that Admission will occur and that dealings will commence at 8.00 a.m. on 25 November 2016 at which time it is also expected that the Placing Shares will be enabled for settlement in CREST.

Use of net proceeds

The net proceeds of the Placing and Subscriptions are expected to be approximately £34.3 million and it is proposed that such proceeds shall be used as follows:

- to fund the continued construction and build-out of the Facility; and
- for general working capital purposes.

Proceeds received the Open Offer, will be used for the same purposes as above.

Details of the Open Offer

The Company is proposing to raise up to £1.6 million before expenses through the Open Offer. A total of 16,000,000 New Ordinary Shares are available to Qualifying Shareholders pursuant to the Open Offer at the Offer Price, payable in full on acceptance. Any Offer Shares not subscribed for by Qualifying Shareholders will be available to Qualifying Shareholders under the Excess Application Facility. The balance of any Offer Shares not subscribed for under the Excess Application Facility will not be available to Placees under the Placing.

Qualifying Shareholders may apply for Offer Shares under the Open Offer at the Offer Price on the following basis:

4 Offer Shares for every 11 Existing Ordinary Shares

and so in proportion for any number of Existing Ordinary Shares held by Qualifying Shareholders on the Record Date. Entitlements of Qualifying Shareholders will be rounded down to the nearest whole number of Offer Shares. Fractional entitlements which would otherwise arise will not be issued to the Qualifying Shareholders but will be aggregated and made available under the Excess Application Facility. The Excess

Application Facility enables Qualifying Shareholders to apply for Excess Shares in excess of their Open Offer Entitlement. Not all Shareholders will be Qualifying Shareholders. Shareholders who are located in, or are citizens of, or have a registered office in Restricted Jurisdictions will not qualify to participate in the Open Offer. The attention of Overseas Shareholders is drawn to paragraph 7 of Part 3 of this document.

Valid applications by Qualifying Shareholders will be satisfied in full up to their Open Offer Entitlements as shown on the Application Form or credited to their CREST account(s). Applicants can apply for less or more than their entitlements under the Open Offer but the Company cannot guarantee that any application for Excess Shares under the Excess Application Facility will be satisfied as this will depend in part on the extent to which other Qualifying Shareholders apply for less than or more than their own Open Offer Entitlements. The Company may satisfy valid applications for Excess Shares of applicants in whole or in part but reserves the right not to satisfy any excess above any Open Offer Entitlement. 7. The Arden Engagement Letter

Pursuant to the terms of the Arden Engagement Letter, Arden Partners agreed to, amongst other things, introduce the Company to potential Placees.

The Arden Engagement Letter provides, *inter alia*, for payment by the Company to Arden Partners of a commission fee of £177,916.60 on the completion of the Transaction, which shall be satisfied through the issue of the Arden Fee Shares to Arden Partners (or any affiliate thereof).

8. The Subscriptions

NG Subscription Agreement

On 31 October 2016 the Company entered into the NG Subscription Agreement with, amongst others, Nikhil Gandhi and SKIL Global pursuant to which, subject to the Resolutions being duly passed, Nikhil Gandhi has agreed to subscribe (whether in his personal capacity or via SKIL Global and/or an affiliate) for the NG Subscription Shares at the Offer Price equal to an aggregate subscription amount of £3.0 million. Mr. Gandhi has agreed to complete the Subscription by 15 January 2017 and, as such, the Company will utilise the £3.0 million received by Mr. Gandhi to fund the continued construction of the Facility in accordance with the planned timetable.

In the event that Nikhil Gandhi does not complete the Subscription for the NG Subscription Shares by 15 January 2017, and in addition to the Company's right to claim for contractual damages, Nikhil Gandhi and SKIL Global have granted a power of attorney in favour of the Company to sell any of the Existing Ordinary Shares currently held by SKIL Global. In such circumstances, the Company shall be entitled to receive the proceeds of any such sale of Existing Ordinary Shares in order to discharge Nikhil Gandhi's non-performance of his obligations under the NG Subscription Agreement. Any sale proceeds received by the Company in excess of £3.0 million (minus all costs, commissions and expenses) shall be paid to Nikhil Gandhi by the Company.

Furthermore, the NG Subscription Agreement provides that:

- the Existing Ordinary Shares held by SKIL Global; and
- the shares in SKIL Global held by Nikhil Gandhi;

in each case, are subject to lock-ins on terms that any interest in any such shares shall only be disposed of with the Company's consent until the earlier of (i) completion of the Subscription by 15 January 2017; or (ii) the Company selling any of the Existing Ordinary Shares currently held by SKIL Global in satisfaction of the liabilities owed to the Company.

Contractor Subscription Agreement

On 31 October 2016, the Company entered into the Contractor Subscription Agreement with ITD pursuant to which, subject to the Resolutions being duly passed, the Company has agreed to issue the Contractor Subscription Shares at the Offer Price, in part payment of amounts to be paid under the EPC Contract. Accordingly, the Company's total cash Funding requirement in relation to the construction of the Facility will be reduced by £3.0 million.

Following the passing of the Resolutions, the relevant New Ordinary Shares are to be issued, conditional upon Admission, to ITD or to such affiliates or third party sub-contractors as it may nominate. ITD has agreed to a lock-in of such shares on terms that any interest in any such shares shall only be disposed of with the Company's consent on or before the Facility becoming fully operational. However, ITD may dispose of shares to its affiliates or third party sub-contractors if such persons agree to the same lock-in terms or if required by law or court order.

9. Effect of Transaction

Upon Admission, the New Ordinary Shares (excluding the NG Subscription Shares) will represent approximately 88.6 per cent. of the Enlarged Share Capital (assuming full take up under the Placing and the Open Offer and that all of the Contractor Subscription Shares are issued).

Certain of the Directors have indicated that they intend to participate in the Transaction, further details of which are set out in the table below.

Nikhil Gandhi's interests are all held indirectly through SKIL Global Ports & Logistics Limited, which is ultimately beneficially owned by Nikhil Gandhi. The table above does not include reference to the NG Subscription Shares which it is anticipated will not be issued until shortly before 15 January 2017. Following the issue of the NG Subscription Shares (and assuming the Placing and Open Offer are fully subscribed and that no other Ordinary Shares are issued in the interim) Nikhil Gandhi's aggregate interest in Ordinary Shares will be 42,720,000 representing 10.17 per cent. of the then issued share capital of the Company.

Relationship Agreement

The Relationship Agreement will terminate upon Admission on the basis that Nikhil Gandhi's interest in the Company, held indirectly via SKIL Global, will fall below 15 per cent. of the voting rights of the Enlarged Share Capital. Upon the expiry of a 12 month period following the termination of the Relationship Agreement, Nikhil Gandhi and SKIL Global will no longer be prohibited from competing with the business of the Group nor will the Group have a right to participate in future projects or opportunities of SKIL Infrastructure Limited. However, assuming completion of the Subscription in accordance with the terms of the NG Subscription Agreement, the Relationship Agreement will be amended and revived and thereafter Nikhil Gandhi's rights and obligations under the Relationship Agreement (including the right to nominate a director to the Board and certain non-compete restrictions) will continue for so long as the personal guarantee granted by Nikhil Gandhi in relation to the Debt Facility remains in full force and effect.

Furthermore, the Relationship Agreement provides that upon its termination, SKIL Global can require that the Company changes its name so that it does not include the word 'SKIL' and, as such, the Company is proposing to change its name to 'Mercantile Ports and Logistics Limited'. Subject to the passing of the relevant Resolution, the change of name of the Company will take effect shortly after Admission.

10. Board change

Jigar Shah was appointed interim finance director at the time of the Company's flotation on the AIM market of the London Stock Exchange on 7 October 2010. Since that time the Company's finance function has been enhanced and Mr Shah's role has diminished. Andrew Henderson was appointed as Head of Finance, a non-board role, on 12 September 2016. Mr Shah currently has no day to day involvement in the Company and has resigned with immediate effect.

11. Related Party Transactions

Legal & General Investment Management ("L&G") is a substantial Shareholder in the Company, holding in aggregate 8,100,000 Ordinary Shares of the Company representing approximately 18.41 per cent. of the voting rights and, consequently L&G is considered to be a related party of the Company pursuant to Rule 13 of the AIM Rules for Companies. L&G is subscribing for 62,500,000 Placing Shares under the Placing. This subscription by L&G also constitutes a related party transaction for the purposes of the AIM Rules for Companies. The Directors consider, having consulted with Cenkos Securities, that the participation in the Placing by L&G is fair and reasonable insofar as the Shareholders are concerned. Assuming that the Placing and the Open Offer are fully subscribed and that all of the Contractor Subscription Shares are issued, L&G's holding in the Company will be approximately 18.10 per cent. of the Enlarged Share Capital.

Nikhil Gandhi is a substantial Shareholder in the Company, holding, via SKIL Global, in aggregate 12,720,000 Ordinary Shares of the Company representing approximately 29.91 per cent. of the voting rights and, consequently Mr. Gandhi is considered to be a related party of the Company pursuant to Rule 13 of the AIM Rules for Companies. Mr. Gandhi has agreed to subscribe for the NG Subscription Shares under the NG Subscription Agreement. This subscription also constitutes a related party transaction for the purposes of the AIM Rules. The Directors (other than Mr. Gandhi) consider, having consulted with Cenkos Securities, that the participation in the Subscription by Mr. Gandhi is fair and reasonable insofar as the Shareholders are concerned. Assuming that the Placing and the Open Offer are fully subscribed and that all of the Contractor Subscription Shares are issued, Mr. Gandhi's holding in the Company will be approximately 3.26 per cent. of the Enlarged Share Capital and following the NG subscription, it will be approximately 10.17 per cent. of the then enlarged share capital.

12. Overseas Shareholders

The attention of Qualifying Shareholders who have registered addresses outside the United Kingdom, or who are citizens or residents of countries other than the United Kingdom, or who are holding Existing Ordinary Shares for the benefit of such persons, (including, without limitation, custodians, nominees, trustees and agents) or who have a contractual or other legal obligation to forward this document or the Application Form to such persons, is drawn to the information which appears in paragraph 7 of Part 3 of this document.

In particular, Qualifying Shareholders who have registered addresses in or who are resident in, or who are citizens of, countries other than the UK (including, without limitation, the United States of America), should consult their professional advisers as to whether they require any governmental or other consents or need to observe any other formalities to enable them to take up their entitlements under the Open Offer.

13. Risk Factors and questions and answers about the Open Offer

The attention of Shareholders is drawn to the risk factors set out in Part 2 and the information contained in Part 4 of this document, which provide some questions and answers about the Open Offer.

14. General Meeting

The Directors do not currently have authority to allot all of the New Ordinary Shares and, accordingly, the Board is seeking the approval of Shareholders at the General Meeting to allot the New Ordinary Shares.

A notice convening the General Meeting, which is to be held at the offices of the Company Secretary, Elian Fiduciary Services (Guernsey) Limited, at Redwood House, St. Julian's Avenue, St. Peter Port, Guernsey, GY1 1WA at 10.00 a.m. on 24 November 2016, is set out at the end of this document. At the General Meeting, the Resolutions will be proposed to authorise the Directors to allot relevant securities equal to 376,000,000 New Ordinary Shares and to authorise the Directors to issue and allot 376,000,000 New Ordinary Shares pursuant to the Placing, the Open Offer and the Subscriptions (and in order to satisfy its payment obligations to Cenkos Securities under the Placing Agreement and Arden Partners under the Arden Engagement Letter) on a non-pre-emptive basis.

The authorities to be granted pursuant to the Resolutions shall expire on whichever is the earlier of the conclusion of the Annual General Meeting of the Company to be held in 2017 or the date falling six months from the date of the passing of the Resolutions (unless renewed, varied or revoked by the Company prior to or on that date) and shall be in addition to the Directors' authorities to allot relevant securities and dis-apply statutory pre-emption rights granted at the Company's Annual General Meeting held on 28 July 2016.

Furthermore, the Board is also seeking the approval of Shareholders at the General Meeting to change the registered name of the Company to 'Mercantile Ports and Logistics Limited'. Subject to the passing of the relevant Resolution, this change of name will take effect shortly after Admission.

15. Action to be taken

In respect of the General Meeting

Please check that you have received a Form of Proxy for use in relation to the General Meeting with this document.

Whether or not you intend to be present in person at the General Meeting, you are strongly encouraged to complete, sign and return your Form of Proxy in accordance with the instructions printed thereon so as to be received, by post or, during normal business hours only, by hand to Capita Asset Services, PXS, 34 Beckenham Road, Beckenham, Kent BR3 4TU, as soon as possible but in any event so as to arrive by not later than 10.00 a.m. on 22 November 2016 (or, in the case of an adjournment of the General Meeting, not later than 48 hours before the time fixed for the holding of the adjourned meeting (excluding any part of a day that is not a business day)).

Appointing a proxy in accordance with the instructions set out above will enable your vote to be counted at the General Meeting in the event of your absence. The completion and return of a Form of Proxy will not preclude you from attending and voting in person at the General Meeting, or any adjournment thereof, should you wish to do so.

In respect of the Open Offer

16. Recommendation

Accordingly the Directors unanimously recommend that Shareholders vote in favour of the Resolutions, as they intend to do in respect of their own holdings of Ordinary Shares, totalling 13,616,000 Ordinary Shares, being approximately 30.95 per cent. of the Existing Ordinary Shares.

The Transaction is conditional, *inter alia*, upon the passing of the Resolutions at the General Meeting. Shareholders should be aware that if the Resolutions are not approved at the General Meeting, the Transaction will not proceed.

PART 2

RISK FACTORS

An investment in the Company is subject to a number of risks and uncertainties. Accordingly, in evaluating whether to make an investment in the Company, potential investors should consider carefully all of the information set out in this document and the risks attaching to an investment in the Company, including (but not limited to) the risk factors described below, before making any investment decision with respect to the New Ordinary Shares. The risk factors described below do not purport to be an exhaustive list and do not necessarily comprise all of the risks to which the Company is exposed or all those associated with an investment in the Company. In particular, the Company's performance is likely to be affected by changes in market and/or economic conditions and in legal, accounting, regulatory and tax requirements. The risk factors described below are not intended to be presented in any assumed order of priority. Additional risks and uncertainties not presently known to the Directors, or which the Directors currently deem immaterial, may also have an adverse effect upon the Company. If any of the following risks were to materialise, the Group's business, financial condition, results, prospects and/or future operations might be materially adversely affected. In such case, the value of the Ordinary Shares might decline and investors might lose all or part of their investment.

GENERAL RISKS

An investment in the Company is only suitable for investors capable of evaluating the risks and merits of such investment and who have sufficient resources to bear any loss that may result from the investment. A prospective investor should consider with care whether an investment in the Company is suitable for him in the light of his personal circumstances and the financial resources available to him. The investment opportunity offered in this document may not be suitable for all recipients of this document. Investors are therefore strongly recommended to consult an investment adviser authorised under FSMA, or such other similar body in their jurisdiction, who specialises in advising on investments of this nature before making a decision to invest.

Investment in the Company should not be regarded as short-term in nature. There can be no guarantee that any appreciation in the value of the Company's investments will occur or that the commercial objectives of the Company will be achieved. RISKS RELATING TO THE GROUP

Lack of revenue

The Group expects to continue to incur losses until such time as the construction of the Facility is completed and the Facility enters into commercial operation and generates sufficient revenues to fund its continuing operations. The completion of the Facility will require the commitment of substantial resources to fund the construction and development of the Facility. There can be no assurance that the Group will generate any revenues or achieve profitability.

Furthermore, the Group has no assets other than the Facility. An investment in the Company is, therefore, highly speculative in that it is based upon the future prospects of the Facility and the ability of the Directors and the Company management to execute on their plans to develop and construct the Facility and similar future projects in order to generate revenue. No assurances can be given that the Facility will be completed on time, if at all, and the failure of the Facility would likely result in a loss of an investment in the Company.

The Transaction is conditional upon Shareholder approval which, if not forthcoming, may have a significant detrimental effect on the future prospects of the Group

The Transaction is conditional, inter alia, upon the Resolutions being passed at the General Meeting of the Company. In the event that the Resolutions are not passed, the Transaction will not be able to proceed and the Company will need to seek alternative sources of funding to secure the £36 million additional amount required in order to complete the build-out of the Facility. Alternative sources of funding, if required, may not be available on terms acceptable to the Company, or at all, and if not available, the Facility may not be capable of completion and this may cause the Group to default on the terms of its Debt Facility and the terms of the Deed of Lease. In such circumstances, the Group's business and the value of any investment in the Company could be significantly diminished.

Estimate of the total funding requirement

Whilst the Directors' anticipate that the Group requires an estimated £36 million by the end of the first quarter of 2017 in order to fund the construction of the Facility to operational completion by, as expected, the end of the third quarter of 2017, this figure is an estimate based on the current information available to the Company. The Group may require additional funds in excess of this figure, whether by virtue of cost overruns due to unforeseeable delays in the construction of the Facility or otherwise. There is a risk that there could be further price inflation of the materials required to construct the Facility and/or the Rupee could strengthen against the pound sterling, increasing the total funding requirement. In addition, there is a risk that alternative sources of any additional funding, if required, may not be available as and when they are required, or on terms acceptable to the Company, or at all, and if not available by the end of the first quarter of 2017 or at all, the Facility may not be capable of completion by, as expected, the end of the third quarter of 2017, or at all. In such circumstances, the Group's business and the value of any investment in the Company could be significantly diminished.

Reliance on Deed of Lease

The Facility is being developed on a 'build, own, operate and transfer' basis and will be transferred free of charge to the Maharashtra Maritime Board at the end of the thirty year lease period set out in the Deed of Lease, being 7 August 2039. The Facility is currently the only business activity of the Group and, therefore, the Group's only source of income will be from the operation of the Facility upon its completion. If the Deed of Lease is terminated early due to default by the Group, whether for failure to pay rent or other charges, or for breach by the Group of the terms and conditions of the Deed of Lease, it would have a material adverse effect on the Group's business, financial condition and results of business.

Operational targets and delays

The Facility is being developed pursuant to the terms of the Deed of Lease with respect to the Project Land upon which the Facility is being built. The operational targets in relation to the Facility, as set out in the Deed of Lease, are subject to the completion of planned operational goals on time and according to budget, and are dependent on the effective support of the Group's personnel, systems, procedures and controls. If the Facility is not constructed and commissioned within the timeframes set out in the Deed of Lease, except due to a force majeure or a change in law, the Maharashtra Maritime Board may require the Group to rectify this non-compliance within six months and, if not so rectified, the Maharashtra Maritime Board may give notice of its intention to terminate the Deed of Lease one calendar month later if the breach is not rectified in that time. Whilst the Maharashtra Maritime Board have waived their right to terminate the Deed of Lease in relation to the delays to the construction of Facility to date, if there are any further delays which result in the Maharashtra Maritime Board exercising their right to terminate the Deed of Lease, this would have a material adverse effect on the Group's business, financial condition and results of operations.

No limitation on rent increases

The Deed of Lease provides that the initial rent for the land for the Facility shall be Rs. 1,70,85,952 per annum (£188,795). However the Deed of Lease provides that the rent may be increased by the State Government of Maharashtra, or by the Maharashtra Maritime Board with the approval of the State

Government of Maharashtra, from time to time. The Deed of Lease does not provide for any limitations on these increases. Increases on the rent for the Facility could have a material adverse effect on the Group's results or operations.

No limit on increases to charges

The Deed of Lease requires the Group to pay cargo and all vessel related charges to MMB in accordance with a scale of rates fixed by MMB. These rates may be increased at MMB's discretion. In addition, the Group is required to pay MMB a minimum guaranteed annual revenue for cargo and all vessel related charges regardless of the actual amount of cargo handled at the Multi-purpose Terminal. A failure to meet these targets may result in the termination of the Deed of Lease. A material increase in the scale of rates payable for cargo and vessel related charges could have a material adverse effect on the Group's financial condition and results of operations. In addition, if the actual cargo handled at the Multi-purpose Terminal is less than that projected by the Group, it could have a material adverse effect on the Group's financial condition and results of operations.

Risks associated with the NG Subscription Agreement

Whilst Nikhil Gandhi has agreed to subscribe for the NG Subscription Shares for aggregate consideration amounting to £3.0 million by 15 January 2017 pursuant to the terms of the NG Subscription Agreement there is no certainty that he will provide such funds to the Company. In the event that Mr. Gandhi fails to complete his Subscription in accordance with the terms of the NG Subscription Agreement, there is a risk that the Company may be unable to enforce fulfillment of Mr. Gandhi's obligations or to sell Mr. Gandhi's Existing Ordinary Shares in the market, or that the sales or perception that such sales could occur, could adversely affect the market price of the Ordinary Shares and may make it more difficult for investors to sell their Ordinary Shares at a time and price which they deem appropriate. In addition, if the Company does not receive the £3.0 million under the NG Subscription Agreement, there is a risk that alternative sources of any additional funding may not be available as and when they are required, or on terms acceptable to the Company, or at all, and if not available by the end of the first quarter of 2017 or at all, the Facility may not be capable of completion by, as expected, the end of the third quarter of 2017, or at all. In such circumstances, the Group's business and the value of any investment in the Company could be worthless.

Effect on the Group's relationship with SKIL Global and Nikhil Gandhi

The Transaction will result in the Relationship Agreement being terminated until the NG Subscription Shares are issued which will reduce the strength of the formal relationship between the Group, SKIL Global and SKIL Infrastructure Limited on the basis that, primarily, the Group will no longer have the preferential right to invest in qualifying projects being undertaken by SKIL Global and SKIL Infrastructure Limited. On Admission, Nikhil Gandhi's equity stake in the Company, held via SKIL Global, will be materially reduced to approximately 3.26 per cent. of the Enlarged Share Capital (albeit that such holding will increase to 10.17 per cent. of the then enlarged share capital following the issue of the NG Subscription Shares (assuming that no additional Ordinary Shares are issued in the interim)). The Relationship Agreement will be revived upon the issue of the NG Subscription Shares and continue for so long as Nikhil Gandhi's personal guarantee in relation to the Debt Facility remains in full force and effect. Although Nikhil Gandhi, in his capacity as Chairman and shareholder of the Company, is still committed to the completion of the Facility, he may, in the future, seek to terminate his personal guarantee granted in relation to the Debt Facility which could affect the future relationship between the Group and its secured lenders under the Debt Facility (albeit that such lenders may not be inclined to agree to any such release) which may have a material adverse effect on the Group's financial condition and results of operations.

Environmental factors

The construction and development of the Facility is subject to environmental regulation (including regular environmental impact assessments and permitting). Such regulation covers a wide variety of matters including, without limitation, prevention of waste, pollution and protection of the environment, labour regulations and worker safety. The Group may also be subject under such regulations to clean-up costs and liability for toxic or hazardous substances which may exist on or under the location of the Facility or which

may be produced as a result of its operations. Environmental legislation and permitting in India are likely to evolve in a manner which will require stricter standards and enforcement, increased fines and penalties for non-compliance, more stringent environmental assessments and a heightened degree of responsibility for companies and their directors and employees.

Construction contracts

The Group is reliant on the provision of contracting services in relation to the Facility from third parties. There can be no assurance that these business relationships will continue to be maintained or that new ones will be successfully formed. A breach or disruption in these relationships could be detrimental to the ability of the Group to complete the Facility which will be detrimental to the future business, operating results and/or profitability of the Group. To the extent that the Group cannot engage contractors according to its plans and budgets, its financial and operational performance may be impaired.

Contractors in India are increasingly reluctant to enter into fixed fee contracts that do not provide for price increases based on increases in the cost of materials or increases in the cost of labour. As such, the Group expects that it will be exposed to the risk of such cost increases. Therefore, any material increase in the actual cost of materials and labour for the construction of the Facility compared to the estimated or contracted costs for materials and labour may have a material adverse effect on the Group's financial condition and results of operations.

Actions of contractors and partners

In certain circumstances, the Group may be liable for the acts or omissions of its contractors or partners. If a third party pursues a claim against the Group as a result of the acts or omissions of the Group's contractors or partners, the Group's ability to recover from such contractors or partners may be limited. Recovery under such arrangements may involve delay, management time, costs and expenses or may not be possible at all which, in each case, could adversely affect the Group's financial performance and condition.

Debt facility

KTLPL entered into a secured rupee term loan of INR 480 crore (£52.99 million) on 28 February 2014 with a syndicate of four Indian public sector banks for a ten year term. The terms of the Debt Facility contain restrictive covenants which, among other things, require the prior approval of lenders, for, among other things, any reorganisation of the Group, amalgamation or merger, incurrence of additional indebtedness, declaring or making any restricted payments, making any investments by way of deposits, loans and share capital, revaluing assets, the disposition of assets beyond permissible limits and expansion of or change in the Group's financing or business plan. There can be no assurance that such approvals will be granted.

In addition the lenders have the right to appoint nominee directors on the Board, to convert at their option the whole or part of any defaulted amount into fully paid up shares of KTLPL or to seek early repayment of the loan.

Any failure to service the Group's indebtedness, maintain the required security interests, comply with requirements to obtain consents or otherwise perform the Group's obligations under its financing arrangements could lead to termination of the facility, enforcement of security over the Group's assets (including the ownership of KTLPL), trigger cross-default provisions, or result in penalties of amounts due under the facility (which will include liquidated damages), which could have a material adverse effect on the Group's business, financial condition and results of operations.

Tax risk

The current tax law (including any double taxation agreements or treaties) and practice of the tax authorities of India (where KTLPL and all of the Group's current assets are held), Cyprus (where KTLCL, the holding company of KTLPL, is based), Guernsey (where the Company is incorporated) and the UK (where the New Ordinary Shares are to be admitted to trading) are subject to change, and any such change could have an adverse effect on the Group's financial condition and results of operations. Changes to the tax residency of

the Company and other members of the Group or changes to the intra-group arrangements could adversely affect the Company's financial condition and results of operations.

Maintenance of tax residency in Guernsey

The Company is incorporated, and is tax resident, in Guernsey and currently pays tax at a rate of nil per cent. in Guernsey. In order to ensure the Company does not become tax resident in any jurisdiction other than Guernsey, the Company is required to be controlled and managed in Guernsey. The composition of the Board, the place of residence of individual members of the Board and the location(s) in which the Board makes decisions will be important in ensuring that the Company does not become tax resident in any jurisdiction other than Guernsey. While the Company is incorporated in Guernsey, continued attention must be addressed to ensure that management and control decisions are made in Guernsey (and not made, for example, in the United Kingdom or India), or the Company may become a tax resident in a jurisdiction other than Guernsey which could have a material adverse effect on the Company's business, financial condition, results of operations, value of the Ordinary Shares and the after-tax return to Shareholders.

Insurance coverage

There are significant operating risks associated with the construction and development of the Facility, including adverse weather conditions and environmental risks, all of which can result in injury to persons as well as damage to or destruction of the plant, equipment, production facilities and other property in relation to the Facility. In addition, the Group will be subject to liability for environmental risks such as pollution and abuse of the environment. Although the Group exercises due care in the conduct of its business and maintains what it believes to be customary insurance for companies in similar operations, the Group is not fully insured against all risk in its business. The occurrence of a significant event against which the Group is not fully insured could have a material adverse effect on its operations and financial performance. In addition, in the future some or all of the Group's insurance coverage may become unavailable or prohibitively expensive.

Retention and hiring of key personnel risk

The Group's future success depends in part on a small number of key individuals, in particular the Directors and senior management employed, and to be employed, by the Group, as well as on its ability to attract employees with relevant expertise. The Group's business may be negatively affected by the departure of any of these individuals. There can be no assurance that the Group will be able to attract and retain personnel on acceptable terms.

Competition

The Facility will primarily compete for business with ports and logistics parks located on the west coast of India. Some of these businesses are owned by companies that have greater financial resources, marketing and other capabilities that those of the Group. There can be no guarantee that the Group will be able to compete successfully against current or future competitors or that increased competitive pressures on the Group will not have a material adverse effect on the Group's business, financial condition and results of operations.

Exposure to international trade and markets

Changes in economic conditions in the United Kingdom, the United States, India, Asia and elsewhere, including, for example, interest rates, fluctuations in currency exchange rates, rates of inflation, industry conditions, political and diplomatic events and trends, tax laws, gross domestic product levels, credit conditions and other factors could have an adverse effect on the financial performance and prospects of the Group.

KTLPL relationship

The Deed of Lease, licences and permits on which the Group relies in relation to the Facility are held by KTLPL. The Group relies on KTLPL maintaining the relevant applications and paying relevant fees in relation to the Deed of Lease, licences and permits which KTLPL holds. To the extent that KTLPL breaches

any of these obligations (whether willfully or due to financial constraints or other issues) the value of the Group as whole could be seriously and adversely affected.

Doing business in India

The Group's assets and operations are located in India which exposes it to risks over which it has no, or limited, control. These may include economic, social or political instability or change, currency non-convertibility or instability and changes of laws affecting foreign ownership, government participation, taxation, working conditions, exchange control and customs duties as well as government control over domestic production which could adversely affect the Group's financial condition and results of operations.

Whilst the Indian economy has sustained growth over the last several years and, therefore the Group's business plan in relation to the Facility is based in part on continued economic growth, any slowdown in the growth of the Indian economy could have an adverse effect on the Group's results of operations and financial condition.

The legal system in India is different to that of the UK. This could result in risks such as: (i) difficulties in obtaining effective legal redress in the courts of such jurisdictions, whether in respect of a breach of law or regulation, or in an ownership dispute; (ii) a higher degree of discretion on the part of governmental authorities; (iii) the lack of judicial or administrative guidance on interpreting applicable rules and regulations; (iv) inconsistencies or conflicts between and within various laws, regulations, decrees, orders and resolutions; (v) relative inexperience of the judiciary and courts in such matters; and (vi) agreements in place may be susceptible to revision or cancellation and legal redress may be uncertain or delayed, the occurrence of any of which could have an adverse effect on the Group's results of operations and financial condition.

Approvals, licences and permits in India

Government approvals, licences and permits are, as a practical matter, subject to the discretion of the applicable governments or government offices. The Group must comply with known standards, existing laws and regulations in India which may entail greater or lesser costs and delays depending on the interpretation of the laws and regulations implemented by the permitting authority. New laws and regulations, amendments to existing laws and regulations, or more stringent enforcement of existing laws and regulations could have a material adverse impact on the Group's results of operations and financial condition.

Furthermore, any failure to obtain or maintain such approvals, licences and permits could result in the Deed of Lease being terminated or other sanctions being imposed which may have a material adverse effect on the Group's operations and financial condition.

Infrastructure and utilities

The Group must use public infrastructure and public utilities such as electricity and water in India for its operations. There is a risk that some of the infrastructure required by the Group may not be available at times required as much of the public infrastructure in India is in a dilapidated or poor condition.

Terrorist attacks, civil unrest or war in or involving India

Terrorist attacks, civil unrest or war in or involving India could have a negative impact on the Indian economy by disrupting communications and making travel more difficult, and such events could create a perception that investments in Indian companies or Indian based projects involve a higher degree of risk. In addition, the Deed of Lease provides that in the event that the Multi-purpose Terminal is required by the Maharashtra Maritime Board or the State Government of Maharashtra due to exigencies of war operations connected with national security, the Group is required to hand over control of the Multi-purpose Terminal until cessation of the circumstances requiring such control. Events of this nature could have an adverse effect on the Group's business, financial condition and results of operations, as well as the price of the Ordinary Shares.

RISKS RELATING TO THE NEW ORDINARY SHARES

Dilution

Existing Shareholders' proportionate ownership and voting interest in the Company will be significantly reduced pursuant to the Placing (whether or not they participate in the Placing or otherwise). Furthermore, Existing Shareholders' proportional ownership and voting interest in the Company will be further reduced pursuant to the Open Offer (whether or not they take up the offer of Offer Shares under the Open Offer or otherwise). Subject to certain exceptions, Existing Shareholders in the United States and other Restricted Jurisdictions will not be able to participate in the Open Offer.

Trading market for the New Ordinary Shares

The Offer Price may not be indicative of the market price for the New Ordinary Shares following Admission. The share price of publicly traded companies, including those listed on AIM, can be highly volatile and shareholdings illiquid. The market price of the Ordinary Shares will be influenced by a large number of factors, which could include, but not be limited to, the performance of both the Group's and its competitors' businesses, variations in the operating results of the Group, divergence in financial results from analysts' expectations, changes in earnings estimates by stock market analysts, large purchases or sales of Ordinary Shares, legislative changes and general economic, political and regulatory conditions. These fluctuations may adversely affect the trading price of the Ordinary Shares, regardless of the Group's performance. Prospective investors should be aware that the value of an investment in the Company may go down as well as up. Investors may therefore realise less than, or lose all of, their investment. The volume of shares traded on AIM can be limited and this may restrict the ability of Shareholders to dispose of Ordinary Shares at any particular time. It may be more difficult for an investor to realise his investment in the Group than in a company whose shares are quoted on the Official List. The AIM Rules for Companies are less demanding than those of the Official List. It is emphasised that no application is being made for the admission of the Company's securities to the Official List.

Additional working capital and dilution

Assuming that the Funding is obtained by the end of the first quarter of 2017, the Directors do not currently anticipate that the Group will require additional working capital to further its strategy. Nevertheless, it is possible that the Group will need or choose to raise extra working capital in the future to finance the development of future projects, to develop fully the Group's business, to take advantage of acquisition opportunities or to respond to new competitive pressures. If the Group is unable to obtain this financing on terms acceptable to it then it may be forced to curtail its development. If additional funds are raised through the issue of new equity or equity-linked securities of the Company other than on a pro rata basis to existing Shareholders, the percentage ownership of such Shareholders may be substantially diluted. There is no guarantee that the then prevailing market conditions will allow for such a fundraising or that new investors will be prepared to subscribe for new Ordinary Shares at the same price as the Offer Price or higher.

Substantial share sales

The Company cannot predict what effect, if any, future sales of Ordinary Shares, or the availability of Ordinary Shares for future sale, will have on the market price of Ordinary Shares. Sales of substantial amounts of Ordinary Shares in the public market following the Placing and Open Offer, or the perception that such sales could occur, could adversely affect the market price of the Ordinary Shares and may make it more difficult for investors to sell their Ordinary Shares at a time and price which they deem appropriate.

Dividends

The Company is a holding company and as such it will only be able to pay dividends to the extent that KTLPL can pay dividends to KTLCL and to the extent that KTLCL can pay dividends to the Company.

Application of Guernsey legislation

The Company is a limited liability company incorporated under the Companies Law. Guernsey law does not make a distinction between private and public companies and some of the protections and safeguards that investors may expect to find in relation to a public company are not provided for under Guernsey law. The rights of Shareholders will be governed by the Companies Law and the articles of incorporation of the Company ("Articles"), as amended from time to time, although the Company has inserted provisions in its Articles and adopted certain procedures to make the Company's governance closer to that of a UK listed company, these do not cover all the differences between applicable law in the UK and in Guernsey. The Company is subject to the Code which provides certain protections to Shareholders in the event of a takeover bid. Should the Ordinary Shares cease to trade on AIM, or should the place of central management and control alter from Guernsey, investors may not however be afforded the protections of the Code.

Taxation

The Group's business model assumes that the tax treatment of the Group remains consistent with the manner in which the Group has accounted for such taxes as at the date of this document. Any changes to the tax regime in the countries it is operating in could have a material adverse effect on the Group's financial performance. The nature and amount of tax which members of the Group expect to pay and the reliefs expected to be available to any member of the Group are each dependent upon a number of assumptions, any one of which may change and which would, if so changed, affect the nature and amount of tax payable and reliefs available. Tax assessments are increasingly based on a system of self-declaration under which tax authorities may open enquiries or investigations several years after the period to which the tax charge relates. Tax charges and liabilities may also therefore be subject to change retrospectively.

The taxation of an investment in the Company depends on the specific circumstances of the relevant investor. Investors should consider carefully whether an investment in the Company is suitable for them in light of the risk factors outlined above, their personal circumstances and the financial resources available to them. This list should not be considered an exhaustive statement of all potential risks and uncertainties.

PART 3

TERMS AND CONDITIONS OF THE OPEN OFFER

Introduction

As explained in the letter from the Chairman set out in Part 1 of this document, the Company is proposing to raise up to £37.6 million by way of the Placing, the Open Offer and the Subscriptions, of which up to approximately £1.6 million (before expenses) may be raised from the offer of the Offer Shares at the Offer Price to Qualifying Shareholders under the Open Offer.

The purpose of this Part 3 is to set out the terms and conditions of the Open Offer. Up to 16,000,000 new Ordinary Shares will be issued through the Open Offer. Qualifying Shareholders are being offered the right to subscribe for Offer Shares in accordance with the terms of the Open Offer. The Open Offer is not being underwritten.

The Record Date for entitlements under the Open Offer for Qualifying CREST Shareholders and Qualifying Non-CREST Shareholders is 5.00 p.m. on 27 October 2016. Application Forms for Qualifying Non-CREST Shareholders accompanying this document will be posted on 31 October 2016 and Open Offer Entitlements are expected to be credited to stock accounts of Qualifying CREST Shareholders in CREST by 1 November 2016.

Subject to availability, the Excess Application Facility will enable Qualifying Shareholders to apply for Excess Shares. Further details in relation to the Excess Application Facility are set out in Part 4 "Questions and Answers about the Open Offer" in this document and, for Qualifying Non-CREST Shareholders, the Application Form.

The latest time and date for receipt of a completed Application Form and payment in full under the Open Offer and settlement of relevant CREST instructions (as appropriate) is 11.00 a.m. on 23 November 2016 with Admission and commencement of dealings in Offer Shares expected to take place at 8.00 a.m. on 25 November 2016.

This document and, for Qualifying Non-CREST Shareholders only, the Application Form, contain the formal terms and conditions of the Open Offer. Your attention is drawn to paragraph 3 of this Part 3 "Terms and Conditions of the Open Offer" which gives details of the procedure for application and payment for the Offer Shares and any Excess Shares applied for pursuant to the Excess Application Facility.

The Offer Shares will, when issued and fully paid, rank equally in all respects with the Existing Ordinary Shares, including the right to receive all dividends or other distributions made, paid or declared, if any, by reference to a record date after the date of their issue.

The Offer Shares will be issued only pursuant to the Open Offer and, subject to as set out in this Part 3, will not otherwise be marketed or made available in whole or in part to the public.

The Open Offer is an opportunity for Qualifying Shareholders to apply for up to 16,000,000 Offer Shares *pro rata* (excepting fractional entitlements) to their current holdings at the Offer Price in accordance with the terms of the Open Offer.

Qualifying Shareholders are also being offered the opportunity to apply for additional Offer Shares in excess of their Open Offer Entitlement to the extent that other Qualifying Shareholders do not take up their Open Offer Entitlements in full. The Excess Application Facility enables Qualifying Shareholders to apply for Excess Shares in excess of their Open Offer Entitlements as at the Record Date.

Any Qualifying Shareholder who has sold or transferred all or part of his/her registered holding(s) of Existing Ordinary Shares prior to the Ex-entitlement Date is advised to consult his or her stockbroker, bank or other agent through or to whom the sale or transfer was effected as soon as possible since the invitation to apply for Offer Shares under the Open Offer may be a benefit which may be claimed from him/her by the purchasers under the rules of the London Stock Exchange.

1. The Open Offer

Subject to the terms and conditions set out below (and, in the case of Qualifying Non-CREST Shareholders, in the Application Form), Qualifying Shareholders are being given the opportunity under the Open Offer to subscribe for Offer Shares at the Offer Price *pro rata* to their holdings of Existing Ordinary Shares as at the Record Date, payable in full on application. The Offer Price represents a discount of 4.8 per cent. to the closing mid-market price of 10.5 pence per Existing Ordinary Share on 28 October 2016 (being the last practicable date before publication of this document).

Qualifying Shareholders have basic entitlements of:

4 Offer Shares for every 11 Existing Ordinary Shares

registered in their name as at 5.00 p.m. on the Record Date. Entitlements under the Open Offer will be rounded down to the nearest whole number of Offer Shares, with fractional entitlements being aggregated and made available under the Excess Application Facility.

Holdings of Existing Ordinary Shares in certificated and uncertificated form will be treated as separate holdings for the purpose of calculating entitlements under the Open Offer, as will holdings under different designations and in different accounts.

If you are a Qualifying Non-CREST Shareholder, the Application Form shows the number of Existing Ordinary Shares registered in your name on the Record Date (in Box 6) and your Open Offer Entitlement (in Box 7).

If you are a Qualifying CREST Shareholder, application will be made for your Open Offer Entitlement and Excess CREST Open Offer Entitlement to be credited to your CREST account. Open Offer Entitlements and Excess CREST Open Offer Entitlements are expected to be credited to CREST accounts on 1 November 2016. The Existing Ordinary Shares are already admitted to CREST. Accordingly, no further application for admission to CREST is required for the New Ordinary Shares. All such shares, when issued and fully paid, may be held and transferred by means of CREST.

The gross proceeds of the Open Offer will amount to a maximum of up to £1.6 million. The Offer Shares (assuming full take up thereunder and that the Placing and Open Offer are fully subscribed and that all of the Contractor Subscription Shares are issued) will represent approximately 4.1 per cent. of the Enlarged Share Capital.

The Offer Shares will, when issued and fully paid, rank in full for all dividends and other distributions declared, made or paid after the date of this document and otherwise *pari passu* in all respects with the Existing Ordinary Shares. The Offer Shares are not being made available in whole or in part to the public except under the terms of the Open Offer.

2. Conditions and further terms of the Open Offer

The Open Offer is conditional on the Placing becoming or being declared unconditional in all respects and not being terminated before Admission. The principal conditions to the Placing are:

- (a) the passing of the Resolutions at the General Meeting;

Qualifying Shareholders who hold all or part of their Existing Ordinary Shares in certificated form will receive the Application Form, enclosed with this document. The Application Form shows the number of Existing Ordinary Shares held at the Record Date. It will also show Qualifying Shareholders their Open Offer Entitlement that can be allotted in certificated form. Qualifying Shareholders who hold all their Existing Ordinary Shares in CREST will be allotted Offer Shares in CREST.

Qualifying Shareholders who hold part of their Existing Ordinary Shares in uncertificated form will be allotted Offer Shares in uncertificated form to the extent that their entitlement to Offer Shares arises as a result of holding Existing Ordinary Shares in uncertificated form. However, it will be possible for Qualifying Shareholders to deposit Open Offer Entitlements into, and withdraw them from, CREST. Further information on deposit and withdrawal from CREST is set out in paragraph 3.2(f) of this Part 3 "Terms and Conditions of the Open Offer".

CREST sponsored members should refer to their CREST sponsor, as only their CREST sponsor will be able to take the necessary action specified below to apply under the Open Offer in respect of the Open Offer Entitlements and Excess CREST Open Offer Entitlements of such members held in CREST. Under the Excess Application Facility, provided they have agreed to take up their Open Offer Entitlement in full, Qualifying Non-CREST Shareholders may apply for more than the amount of their Open Offer Entitlement should they wish to do so. The Excess Application Facility enables Qualifying Shareholders to apply for Excess Shares in excess of their Open Offer Entitlement as at the Record Date. The Excess Shares may be allocated in such manner as the Directors may determine in their absolute discretion and no assurance can be given that excess applications by Qualifying Shareholders will be met in full or in part or at all.

The instructions and other terms set out in the Application Form form part of the terms of the Open Offer in relation to Qualifying Non-CREST Shareholders.

(b) Bona fide market claims

Qualifying Non-CREST Shareholders who have sold all or part of their registered holding should, if the market claim is to be settled outside CREST, complete Box 10 on the Application Form and immediately send it to the stockbroker, bank or other agent through whom the sale or transfer was effected for transmission to the purchaser or transferee. Qualifying Non-CREST Shareholders should note that applications, once made, will be irrevocable and receipt thereof will not be acknowledged. Multiple applications will not be accepted. If an Application Form is being sent by first-class post in the UK, Qualifying Non-CREST Shareholders are recommended to allow at least four Business Days for delivery.

Subject as provided in paragraph 7 of this Part 3 in relation to Overseas Shareholders, the CREST accounts of Qualifying CREST Shareholders will be credited with Excess CREST Open Offer Entitlements to enable applications for Excess Shares to be settled through CREST. Qualifying CREST Shareholders should note that, although the Open Offer Entitlement and the Excess CREST Open Offer Entitlements will be admitted to CREST, they will have limited settlement capabilities. Neither the Open Offer Entitlement nor the Excess CREST Open Offer Entitlements will be tradable or listed and applications in respect of the Open Offer may only be made by the Qualifying Shareholders originally entitled or by a person entitled by virtue of a bona fide market claim.

On 25 November 2016, the Receiving Agents will instruct Euroclear to credit the appropriate stock accounts of Qualifying CREST Shareholders with such Qualifying CREST Shareholders' entitlements to Offer Shares with effect from Admission. The stock accounts to be credited will be accounts under the same CREST participant IDs and CREST member account IDs in respect of which the USE instruction was given. Receipt of this document and/or an Application Form and/or a credit of an Open Offer Entitlement to a stock account in CREST will not constitute an invitation or offer of securities for subscription, sale or purchase in the Restricted Jurisdictions and in those other jurisdictions in which it would be illegal to make such an invitation or offer and, in those circumstances, this document and/or the Application Form must be treated as sent for information only and should not be copied or redistributed.

7.2 United States

The Offer Shares have not been and will not be registered under the Securities Act or with any securities regulatory authority of any state or other jurisdiction of the United States and, accordingly, may not be offered or sold, re-sold, taken up, transferred, delivered or distributed, directly or

indirectly, within the United States except in reliance on an exemption from, or in a transaction not subject to, the registration requirements of the Securities Act and in compliance with any applicable securities laws of any state or other jurisdiction of the United States.

Accordingly, the Company is not extending the Open Offer into the United States unless an exemption from the registration requirements of the Securities Act is available and, subject to certain exceptions, neither this document nor the Application Form constitutes or will constitute an offer or an invitation to apply for or an offer or an invitation to acquire any Offer Shares in the United States. Subject to certain exceptions, neither this document nor an Application Form will be sent to, and no Offer Shares will be credited to a stock account in CREST of, any Qualifying Shareholder with a registered address in the United States. Subject to certain exceptions, Application Forms sent from or postmarked in the United States will be deemed to be invalid and all persons acquiring Offer Shares and wishing to hold such Offer Shares in registered form must provide an address for registration of the Offer Shares issued upon exercise thereof outside the United States.

Subject to certain exceptions, any person who acquires Offer Shares will be deemed to have declared, warranted and agreed, by accepting delivery of this document or the Application Form and delivery of the Offer Shares, that they are not, and that at the time of acquiring the Offer Shares they will not be, in the United States or acting on behalf of, or for the account or benefit of a person on a non-discretionary basis in the United States.

The Company and Cenkos Securities reserves the right to treat as invalid any Application Form that appears to the Company and Cenkos Securities or their agents to have been executed in, or despatched from, the United States, or that provides an address in the United States for the receipt of Offer Shares, or which does not make the warranty set out in the Application Form to the effect that the person completing the Application Form does not have a registered address and is not otherwise located or resident in the United States and is not acquiring the Offer Shares with a view to the offer, sale, resale, transfer, delivery or distribution, directly or indirectly, of any such Offer Shares in the United States or where the Company and Cenkos Securities believe acceptance of such Application Form may infringe applicable legal or regulatory requirements.

The Company will not be bound to allot or issue any Offer Shares to any person with an address in, or who is otherwise located or resident in, the United States in whose favour an Application Form or any Offer Shares may be transferred. In addition, the Company reserves the right to reject any USE instruction sent by or on behalf of any CREST member with a registered address in the United States in respect of the Offer Shares. In addition, until 40 days after the commencement of the Open Offer, an offer, sale or transfer of the New Ordinary Shares within the United States by a dealer (whether or not participating in the and Open Offer) may violate the registration requirements of the Securities Act.

7.3 Restricted Jurisdictions

Due to restrictions under the securities laws of the Restricted Jurisdictions and subject to certain exceptions, Shareholders who have registered addresses in, or who are resident or ordinarily resident in, or citizens of, any Restricted Jurisdiction will not qualify to participate in the Open Offer and will not be sent an Application Form nor will their stock accounts in CREST be credited with Open Offer Entitlements or Excess CREST Open Offer Entitlements. The Offer Shares have not been and will not be registered under the relevant laws of any Restricted Jurisdiction or any state, province or territory thereof and may not be offered, sold, resold, delivered or distributed, directly or indirectly, in or into any Restricted Jurisdiction or to, or for the account or benefit of, any person with a registered address in, or who is resident or ordinarily resident in, or a citizen of, any Restricted Jurisdiction except pursuant to an applicable exemption.

No offer or invitation to apply for Offer Shares is being made by virtue of this document or the Application Form into any Restricted Jurisdiction.

7.4 Other overseas territories

Application Forms will be sent to Qualifying Non-CREST Shareholders and Open Offer Entitlements and Excess CREST Open Offer Entitlements will be credited to the stock account in CREST of Qualifying CREST Shareholders. Qualifying Shareholders in jurisdictions other than the United States or the other Restricted Jurisdictions may, subject to the laws of their relevant jurisdiction, take up Offer Shares under the Open Offer in accordance with the instructions set out in this document and the Application Form. Qualifying Shareholders who have registered addresses in, or who are resident or ordinarily resident in, or citizens of, countries other than the United Kingdom should, however, consult appropriate professional advisers as to whether they require any governmental or other consents or need to observe any further formalities to enable them to apply for any Offer Shares in respect of the Open Offer.

7.5 Representations and warranties relating to Overseas Shareholders

(a) Qualifying Non-CREST Shareholders

Any person completing and returning an Application Form or requesting registration of the Offer Shares comprised therein represents and warrants to the Company, Cenkos Securities and the Receiving Agents that, except where proof has been provided to the Company's satisfaction, in its sole and absolute discretion, that such person's use of the Application Form will not result in the contravention of any applicable legal requirements in any jurisdiction: (i) such person is not requesting registration of the relevant Offer Shares from within the United States or any other Restricted Jurisdiction; (ii) such person is not in any territory in which it is unlawful to make or accept an offer to acquire Offer Shares in respect of the Open Offer or to use the Application Form in any manner in which such person has used or will use it; (iii) such person is not acting on a non-discretionary basis for a person located or resident within any Restricted Jurisdiction (except as agreed with the Company) or any territory referred to in (ii) above at the time the instruction to accept was given; and (iv) such person is not acquiring Offer Shares with a view to offer, sale, resale, transfer, deliver or distribute, directly or indirectly, any such Offer Shares into any of the above territories. The Company and/or the Receiving Agents may treat as invalid any acceptance or purported acceptance of the allotment of Offer Shares comprised in an Application Form if it: (i) appears to the Company or its agents to have been executed, effected or dispatched from the United States or another Restricted Jurisdiction, by a person who has a registered address in the United States or any other Restricted Jurisdiction, or on behalf of such a person by his or her agent or intermediary, or in a manner that may involve a breach of the laws or regulations of any jurisdiction or if the Company or its agents believe that the same may violate applicable legal or regulatory requirements; or (ii) provides an address in the United States or another Restricted Jurisdiction for delivery of the share certificates of Offer Shares (or any other jurisdiction outside the United Kingdom in which it would be unlawful to deliver such share certificates); or (iii) purports to exclude the warranty required by this sub-paragraph (a).

(b) Qualifying CREST Shareholders

7.6 Waiver

The provisions of this paragraph 7 and of any other terms of the Open Offer relating to Overseas Shareholders may be waived, varied or modified as regards specific Shareholders or on a general basis by the Company in its sole and absolute discretion with the prior written approval of Cenkos Securities. Subject to this, the provisions of this paragraph 7 supersede any terms of the Open Offer inconsistent herewith. References in this paragraph 7 to Shareholders shall include references to the person or persons executing an Application Form and, in the event of more than one person executing an Application Form, the provisions of this paragraph 7 shall apply to them jointly and to each of them.

8. Times and Dates

The Company shall, in agreement with Cenkos Securities and after consultation with its financial and legal advisers, be entitled to amend the dates that Application Forms are despatched or amend or extend the latest date for acceptance under the Open Offer and all related dates set out in this document and in such circumstances shall notify the London Stock Exchange, and make an announcement on a Regulatory Information Service but Qualifying Shareholders may not receive any further written communication.

If a supplementary circular is issued by the Company two or fewer Business Days prior to the latest time and date for acceptance and payment in full under the Open Offer specified in this document, the latest date for acceptance under the Open Offer shall be extended to the date that is three Business Days after the date of issue of the supplementary circular (and the dates and times of principal events due to take place following such date shall be extended accordingly).

9. Taxation

Shareholders who are in any doubt as to their tax position in relation to taking up their entitlements under the Open Offer, or who are subject to tax in any jurisdiction other than the United Kingdom, should immediately consult a suitable professional adviser.

10. Further information

Your attention is drawn to the further information set out in this document and also, in the case of Qualifying Non-CREST Shareholders and other Qualifying Shareholders to whom the Company has sent Application Forms, to the terms, conditions and other information printed on the accompanying Application Form.

11. Governing law and jurisdiction

The terms and conditions of the Open Offer as set out in this document, the Application Form and any non-contractual obligation related thereto shall be governed by, and construed in accordance with, English law.

The courts of England and Wales are to have exclusive jurisdiction to settle any dispute which may arise out of or in connection with the Open Offer, this document or the Application Form. By taking up Offer Shares, by way of their Open Offer Entitlements and the Excess Application Facility (as applicable), in accordance with the instructions set out in this document and, where applicable, the Application Form, Qualifying Shareholders irrevocably submit to the jurisdiction of the courts of England and Wales and waive any objection to proceedings in any such court on the ground of venue or on the grounds that proceedings have been brought in an inconvenient forum.

QUESTIONS AND ANSWERS ABOUT THE OPEN OFFER

The questions and answers set out in this Part 4 "Questions and Answers about the Open Offer" are intended to be in general terms only and, as such, you should read Part 3 "Terms and Conditions of the Open Offer" of this document for full details of what action to take. If you are in any doubt as to the action you should take, you are recommended to seek your own personal financial advice immediately from your stockbroker, bank, fund manager, solicitor, accountant or other appropriate independent financial adviser, who is authorised under FSMA if you are in the United Kingdom or, if not, from another appropriately authorised independent financial adviser.

This Part 4 deals with general questions relating to the Open Offer and more specific questions relating principally to persons resident in the United Kingdom who hold their Existing Ordinary Shares in certificated form only. If you are an Overseas Shareholder, you should read paragraph 7 of Part 3 "Terms and Conditions of the Open Offer" of this document and you should take professional advice as to whether you are eligible for, and/or whether you need to observe any formalities to enable you to take up, your Open Offer Entitlement. If you hold your Existing Ordinary Shares in uncertificated form (that is, through CREST) you should read Part 3 "Terms and Conditions of the Open Offer" of this document for full details of what action you should take.

If you are a CREST sponsored member, you should also consult your CREST sponsor. The contents of this document should not be construed as legal, business, accounting, tax, investment or other professional advice. Each prospective investor should consult his, her or its own appropriate professional advisers for advice. This document is for your information only and nothing in this document is intended to endorse or recommend a particular course of action.

1. What is an open offer?

An open offer is a way for companies to raise money. Companies usually do this by giving their existing Shareholders a right to acquire further shares at a fixed price in proportion to their existing shareholdings. In this instance Shareholders will also be offered the opportunity to apply for additional shares in excess of their entitlement to the extent that other Qualifying Shareholders do not take up their entitlement in full. The fixed price is normally at a discount to the market price of the existing ordinary shares prior to the announcement of the open offer.

This Open Offer is an invitation by the Company to Qualifying Shareholders to apply to acquire up to an aggregate of 16,000,000 new Ordinary Shares at a price of 10 pence per share. If you hold Existing Ordinary Shares on the Record Date or have a bona fide market claim, other than, subject to certain exceptions, where you are a Shareholder with a registered address or located or resident in the United States, or another Restricted Jurisdiction, you will likely be entitled to buy Offer Shares under the Open Offer.

The Open Offer is being made on the basis of 4 Offer Shares for every 11 Existing Ordinary Shares held by Qualifying Shareholders on the Record Date. If your entitlement to Offer Shares is not a whole number, you will not be entitled to buy a fraction of an Offer Share and your entitlement will be rounded down to the nearest whole number. 3. I hold my Existing Ordinary Shares in certificated form. How do I know how many Offer Shares I am entitled to take up?

- how much you need to pay if you want to take up your right to buy all your entitlement to the Offer Shares.

4. I hold my Existing Ordinary Shares in certificated form and am eligible to receive an Application Form. What are my choices in relation to the Open Offer?

(a) If you do not want to take up your Open Offer Entitlement

If you do not want to take up the Offer Shares to which you are entitled, you do not need to do anything. In these circumstances, you will not receive any Offer Shares. You will also not receive any money when the Offer Shares you could have taken up are sold, as would typically happen under a rights issue.

You cannot sell your Application Form or your Open Offer Entitlement to anyone else. 7. Can I trade my Open Offer Entitlement?
